## **PRIVACY NOTICE**

National Youth Ballet (NYB) is a registered charity no. 1000932. We are committed to protecting your privacy and will only use your personal information in accordance with the Data Protection Act 1998 (DPA), Privacy and Electronic Communications Regulations (PECR), General Data Protection Regulation 25 May 2018 (GDPR) and other relevant legislation.

Our Privacy Notice is set out below: please read it with care as it describes how we will process your data and that of your children.

### **Data Security and Storage**

We collect and store personal and non-personal data that you may volunteer as part of registering, auditioning or via donation forms, e-news sign-ups, visitor surveys or in connection with a specific project or event.

Personal Data information we collect may include:

- Your full name and title and date of birth
- Postal address, email address and phone number and emergency contacts
- Medical conditions and GP details
- IP (internet protocol) address
- Gift Aid status
- Payment card details (these are not stored, except if you have requested an Automatic Renewal Membership when they are stored securely by PayPal, an approved third party)
- Your contact and communication preferences

### **Sensitive Personal Data that we will Collect**

The Data Protection Act gives special protection to sensitive personal data which will include information relating to health or sex life, race or ethnic origin, political beliefs or membership, philosophical or religious beliefs, trade union membership and information about the commission of offences and related proceedings. You should only provide this information if it is required in response to a mandatory question on our websites, or if you are otherwise content for us to process this information

### **Non-personal information we Collect Includes**

IP addresses (the location of the computer on the internet); web pages accessed; and files downloaded. This helps us to determine how many people use our website, how regularly they visit, and how popular our webpages are. This information does not tell us anything about who you are or where you live, but it does help us monitor and improve our service.

NYB will from time to time take photographs and film footage of students during class time for use in NYB marketing and publicity material (both online and offline). If you do not wish for your child to be photographed/filmed please let NYB know in writing.

We store personal data under strict safekeeping and confidentiality measures on secure servers operated by NYB and stored securely by Spektrix, our ticketing, marketing and fundraising systems provider. All Spektrix servers are located in a Tier IV data centre in the UK, which has 24/7 onsite security and tightly restricted access control. Only authorised NYB staff who need to process your data will have access to it.

By disclosing your personal information to us via [nationalyouthballet.org](https://nationalyouthballet.org), by phone or in writing, you are giving us your consent to collect, store and process your personal information in the manner described in this Notice. The information we hold will be accurate and up-to-date within our knowledge.

While we cannot ensure or guarantee that loss, misuse or alteration of data will not occur when it is under our control, we use our best efforts to try to prevent this. Unfortunately, the transmission of data across the internet is not completely secure and while we do our best to try to protect the security of your information we cannot ensure or guarantee that loss, misuse or alteration of data will not occur while data is being transferred.

We will use the information you provide to:

- Provide the appropriate care for your child whilst in our care at Summer School and the Theatres
- To analyse the gender and race percentages that will be shown within our program as statistics.
- Process sales transactions, donations or other payments and verify financial transactions
- Fulfil your requests – such as applications for membership, donations, competition entries, participation in campaigns and provision of information
- Identify visitors and contributors
- Handle and deliver orders and communicate with you about them
- Provide a personalised service to you when you visit our website. This could include customising the content and/or layout of our pages for individual users
- Record any contact we have with you
- Prevent or detect fraud or abuses of our website and enable third parties to carry out technical, logistical or other functions on our behalf in relation to prevention and detection
- Carry out research on the demographics, interests and behaviour of our users and supporters to help NYB gain a better understanding of them and to enable us to improve our service. This research is usually carried out internally by our employees unless we notify you otherwise and have your prior consent.
- Communicate with our customers and supporters

## **Sharing Information**

To undertake our business activities we sometimes have to share your information with third parties such as:

- Database and IT providers
- Mailing house which handles our direct postal communications
- City Councils for Body of Persons Licence applications
- Theatres used for NYB activities
- Residential Schools used for NYB activities
- HMRC for gift aid purposes

We only choose partners we trust and will only pass personal data to them if they have signed a contract that requires them to:

- abide by the requirements of the Data Protection Act
- treat your information as carefully as we would
- only use the information for the purposes it was supplied (and not for their own purposes or the purposes of any other organisation)
- allow us to carry out checks to ensure they are doing all these things

We do not share or sell your personal information for other organisations to use for their own purposes, unless it is for the reasons given above.

As a charity, NYB fundraises from individuals, companies, public bodies and private trusts and foundations. This includes approaching those who want to support our mission to inspire as many children as possible and from all backgrounds by enabling them to experience thrilling, innovative, outstanding ballet excellence and creative learning opportunities in a welcoming space that they can call their own. Fundraising also helps to ensure the financial viability of NYB as we strive to achieve our ambition to develop and improve our activities and outreach programmes for the long-term future.

When fundraising, we may undertake research to explore shared interests with potential supporters. We will not use third-party profiling companies but may use profiling and screening techniques ourselves to analyse your personal data and create a profile of your interests and preferences. We may also make use of additional information about you including where you live, your age and similar demographics, and any publicly-available information (for example through LinkedIn, Companies House, Charity Commission).

We want to contact you only when it may be relevant. By better understanding the background of our supporters we are able to make only the most appropriate requests for gifts that will help us continue to make innovative and outstanding theatre and learning programmes for children created by the most talented artists, develop talent and make live theatre accessible to children with wide ranging additional needs and from all backgrounds.

## **Children and Vulnerable Adults**

We are committed to safeguarding children, young people and vulnerable adults and do all we can to ensure that all who work at NYB, including volunteers, whether on stage or joining an education

project, are safe and inspired by their experience. An important part of doing this is to protect their privacy.

If you are aged 16 or under, please obtain your parent/guardian's permission every time before you provide any personal information; we will always require their signature on any documentation when you sign up to a NYB project or are contracted to perform with us. We will always require the carer's signature on similar documentation relating to vulnerable adults.
